HOW TO CLAIM

If a driver chooses an Ohme charger

Your CUPRA retailer will register the driver on the Ohme portal, sharing your driver's personal data with Ohme and CUPRA for validation. Once approved, Ohme will contact your driver directly to arrange the installation.

If a driver chooses a CUPRA Charging voucher

Drivers opting for the £700 CUPRA charging credit will have their requests registered by the supplying retailer. Once their request is validated, they will be issued a voucher code via email, which must be activated via the My CUPRA app:

- Download the app
- Subscribe to My CUPRA charging
- Enter the Vehicle Identification Number (VIN)
- Select a tariff and enter voucher code
